General Description

The MP120KA mounting plate is designed to allow the use of 120 VAC to power SpectrAlert Advance horns, strobes, horns/strobes, chimes, and chime/strobes. The MP120KA consists of a SpectrAlert Advance mounting plate that has been fitted with a power supply that converts 120VAC to nominal 24V FWR.

The MP120KA must be installed using a 120 VAC power source. This unit can only be used for non-synchronous applications; it will NOT work with SpecrtAlert Sync•Circuit Modules and is not to be used in CAN/ULC-S527 applications which is for fire alarm systems.



This module has pig-tail wires and is intended to be wired without rigid connections inside a standard electrical box.


Figure 1. Non-synchronized devices; any combination of models powered by a 2-wire circuit.


1. For indoor applications, attach the mounting plate as shown in Figure 2. The mounting plate is compatible only with 4 × 4 electrical boxes. The 4x4 electrical box must be mounted with it's mounting holes on the side as shown in figure 2.

NOTE: The MP120KA is not weatherproof. When used in an outdoor application, the product must be installed using the proper SpectrAlert Advance watertight junction box and an outdoor listed horn/strobe. The wall mount watertight junction box must be mounted with its internal post in the lower left corner as shown in Figure 3.

- 2. Complete field wiring.
- 3. If the product is not to be installed at this point, use the cover to prevent contamination of the wiring terminals of the mounting plate.
- 4. To attach product to mounting plate, hook tabs on the product housing into the grooves on mounting plate. Then, swing product into position to engage the pins on the product with the terminals on the mounting plate. Make sure that the tabs on the back of the product housing fully engage with the mounting plate.
- 5. Secure product by tightening the single mounting screw in the front of the product housing.

NOTE: Standard captured mounting screw may be replaced with enclosed torx screw for tamper resistance.
