### **GLOVE DESCRIPTION**

This glove offers good all around performance. They are suitable for most construction work like brick handling and general assembly work operations.


Natural rubber coating in combination with polyester/cotton liner provide excellent grip and finger sensitivity. Uncoated area on the back to assist ventilation and comfort. Knit wrist to prevent ingress of foreign matters.

#### **CLEANING/MAINTENANCE**

Both new and used gloves should be thoroughly inspected, especially after cleaning treatment, before being worn to ensure no damage is present. Gloves should not be left in contaminated condition if re-use is intended in which case gloves should be cleaned as far as possible provided no serious hazard exists, before removal from hand. Excess contamination should first be removed and the gloves may be decontaminated with mild detergent solution then rinsed with clean water and dried ideally with some air movement. When contaminant is not removable or presents a potential hazard it is advisable to ease left and right gloves off alternately using the gloved hand so that the gloves are removed without the contaminant contacting bare hands.

#### STORAGE

Gloves should be ideally stored in dry and cool conditions, sheltered from direct light in original package.

#### **OBSOLESCENCE**

When stored as recommended will not suffer change in mechanical properties for up to five years from the date of manufacture. Service life cannot be specified and depends on application and responsibility of user to ascertain suitability of the glove for its intended use.
