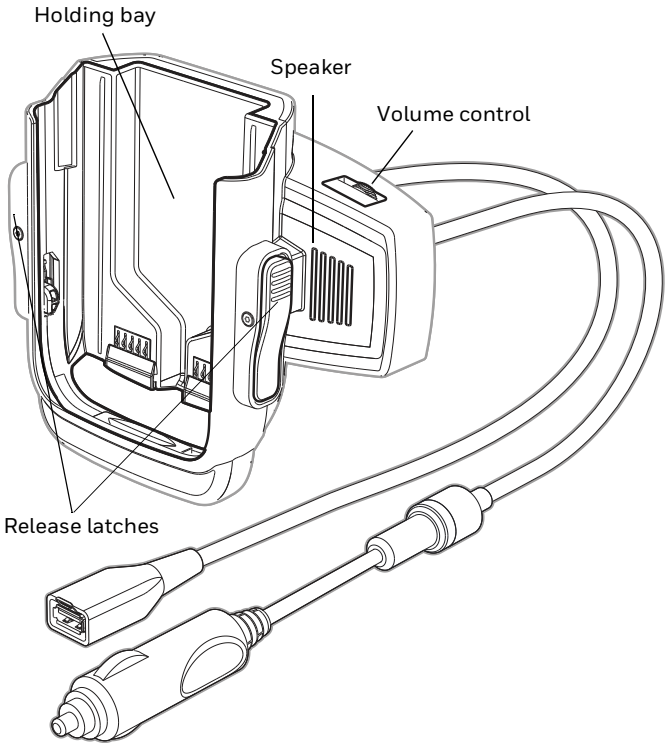

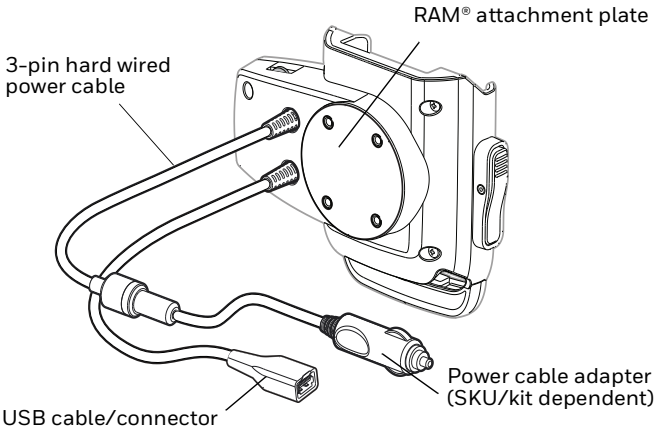


Connect Power

The vehicle that you connect the Vehicle Dock to should supply 2 A to the device. The operating temperature is -20 °C to 50 °C (-4 °F to 122 °F).

1. Connect the power cable adapter to a fused 12V power source on the vehicle.
 - When using the power adapter cable (shown in the image below), insert the adapter into the power socket.
 - When connecting to a vehicle fuse block using vehicle power connection kit 226-109-003 or 226-109-004 (sold separately), a qualified technician should perform the installation.

Note: If you require charging capabilities while the vehicle is turned off, connect the vehicle dock to an unswitched 12V source.
2. Screw the 3-pin connector on the vehicle dock power cable into the connector on the power cable adapter (SKU/kit dependent).
3. (Optional) Connect a secondary device (e.g., laptop, scanner, printer) to the USB communication cable on the vehicle dock. The USB cable can be mounted to a panel/bulkhead if desired. It can be tied out of the way if it is not used.

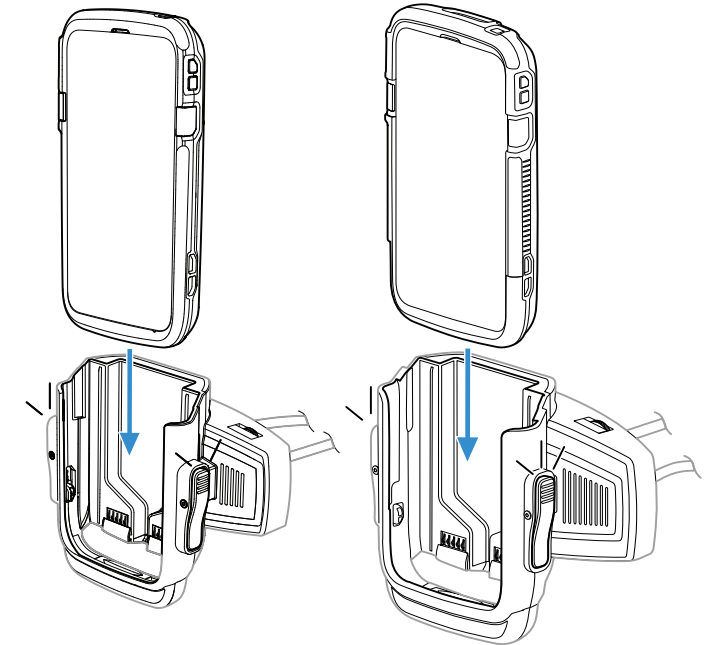


Charge the Device

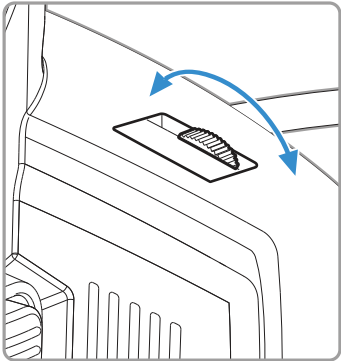
- Insert the device with battery installed into the vehicle dock until the latches click.



About the Volume Control

The vehicle dock has a built in volume control to enable you to hear the device in noisy environments.

- Rotate the volume control counter-clockwise to raise the volume.
- Rotate the volume control clockwise to lower the volume.



Mount the Vehicle Dock

You can mount the vehicle dock to your vehicle with a RAM mount.
