Figure 1. Current Sourcing Output Block Diagram





Figure 2. Transfer Characteristics ( $V_s = 5.0 \text{ Vdc}$ )



### SOLDERING/ASSEMBLY

## CAUTION

### **SOLDERING INSTRUCTIONS**

- Ensure leads are adequately supported during any forming/shearing operation so that they are not stressed inside the plastic case.
- Limit exposure to high temperatures.

Through-hole leads: Wave solder at 250 °C to 260 °C [482 °F to 500 °F] for 3 s max.

Surface-mount: Use an infrared reflow process with temperatures of 245 °C [473 °F] peak for 10 s max.

#### **CLEANING**

Use agitated rinse. Do not use pressure wash. High-pressure stream could force contaminants into package.

Figure 3. Null Shift versus Temperature






Figure 4. Sensitivity Shift versus Temperature




Figure 7. Sensitivity per Volt versus Vs








Figure 8. SS39ET Mounting Dimensions (for reference only, mm/[in]) 2,90 [0.114] NOMINAL IC CENTER 2,80 [0.110] ] 1,60 <sup>-</sup> [0.063] |**←**3X 0,50 [0.20] 0,95 [0.037] 1,90 [0.075] NOMINAL TO IC SENSING 0,413\_ [0.016] 0,77 [0.030] 1,45 [0.057] 0,787 [0.031] \_ 0,60 [0.024] S S
